The primary focus of ARC is to educate the public on the crisis in Syria, the widespread of its refugees and the need for international, cross-cultural humanitarian aid resulting from the crisis and its ramifications. ARC provides member organizations with benefits that include improving organizational infrastructure, share best practices, and nonprofit training and capacity building. During 2016, ARC ran a public awareness campaign to educate the American public on the plight of refugees and civilians in Syria. This public awareness campaign achieved over 30 media hits and potentially reached an estimated 11.6 million people. ARC also provided two in person/by-phone trainings for all 13 member organizations on the topics of Media Interviews and Restrictions on Nonprofit Lobbying. ARCS collaborated with another nonprofit to design and provide online nonprofit management training curriculum to all 13 member organizations and their staff.
